

RESOLUTION NO. 2-03-18

A RESOLUTION OF THE HENRY COUNTY, TENNESSEE, BOARD OF COMMISSIONERS TO QUITCLAIM AND RELEASE OF COVENANTS AND RESTRICTIONS CERTAIN PROPERTIES IN HENRY COUNTY

WHEREAS, the undersigned parties to this instrument are all owners of all lots located within that certain subdivision situated in the Seventh Civil District of Henry County, Tennessee, known as The Meadows Subdivision (plat of which is recorded in Plat Cabinet E, Slide 7, Register's Office of Henry County, Tennessee) and the owner of a tract adjoining said subdivision which is described in Record Book 86, Page 127, which are assessed for taxation at Map 095, Parcel 047.00, and Map 095D, Group E, Parcels 001.00–013.00, to wit: **LANE HAWLEY MCINTOSH; ANDERS TYE DOLL; RONALYN FELICIANO DOLL; ED REAGOR, SR. and wife, NANCY REAGOR; PAUL P. KLUWE and wife, GENA K. KLUWE; JENNIFER L. BICKOWSKI; SAMUEL G. WOODROW and wife, MARY H. WOODROW; JENNIFER L. BICKOWSKI; FRANK EUGENE ANNARATONE, and wife, MARY RUTH ANNARATONE; and LORIE GENAN PENDERGRASS (BEING ONE AND THE SAME AS LORIE GENAN CAIN)** (collectively "**First Party**") and the Government of **HENRY COUNTY, TENNESSEE** ("**Second Party**").

WHEREAS, the First Party desires that the right-of-way known as Fieldstone Drive, which is depicted on the plat of Meadows Subdivision, Plat Cabinet E, Slide 7, Register's Office of Henry County, Tennessee, become a public county road; and

WHEREAS, there are certain Covenants and Restrictions pertaining to The Meadows Subdivision of record in Record Book 103, Pages 394–405, Register's Office of Henry County, Tennessee, which conflict with the dedication of Fieldstone Drive as a public road;

NOW THEREFORE, in consideration of the mutual promises herein, the parties agree as follows:

The First Party agree among themselves to forever waive and terminate any and all covenants and restrictions pertaining to Fieldstone Drive and the gate located at or about the intersection of Fieldstone Drive and India Road, including without limitation § 1.52 of the Covenants and Restrictions recorded at Record Book 103, Pages 394–405, Register's Office of Henry County, Tennessee.

Ed Reagor, Sr. and wife, Nancy Reagor agree to remove the aforementioned gate within 90 days of the recording of this instrument, and the First Party consents to removal of the gate.

The First Party quitclaims to the Second Party the entirety of Fieldstone Drive as depicted on the plat of The Meadows Subdivision, Plat Cabinet E, Slide 7, Register's Office of Henry County, Tennessee, and grant Second Party a perpetual easement to access and use the land between Fieldstone Drive and the building setback lines as depicted on said plat for purposes of maintaining Fieldstone Drive.

The First Party agree that Fieldstone Drive be dedicated a public county road; waive any right to notice regarding the opening of Fieldstone Drive as a public county road pursuant to TENN. CODE ANN. § 54-10-202 or otherwise; waive the right to a convening of a jury of view pursuant to TENN. CODE ANN. § 54-10-204; and waive any right to compensation or damages by reason of the opening of Fieldstone Drive as a public county road pursuant to TENN. CODE ANN. § 54-10-205 or otherwise; and waive their right to appeal the opening of Fieldstone Drive as a public county road.

David W. Bickowski and wife, Jennifer L. Bickowski owned Lot No. 12 of the Meadows Subdivision, jointly as husband and wife. David W. Bickowski died May 05, 2011, leaving his wife Jennifer L. Bickowski as sole owner and tenant in fee simple.

WHEREAS, Section 8, Chapter 326 of the Private Acts of 1972 requires the County Commission to act on the recommendation of the Road Board "in accordance with the General State Law."

**A RESOLUTION OF THE HENRY COUNTY, TENNESSEE BOARD
OF COMMISSIONERS TO ADD FIELDSTONE DRIVE INTO THE
COUNTY ROAD SYSTEM**

WHEREAS, the enabling legislation, known as the Henry County Road Law, provides that the Henry County Commission will open and close all roads on behalf of Henry County; and

WHEREAS, the Henry County Highway Commission recommends the addition of Fieldstone Drive into the Henry County Road System; and

WHEREAS, by instrument recorded in Record Book 484, Page 312 in the Henry County Register of Deeds Office, all landowners adjoining Fieldstone Drive have quitclaimed their interest in said roadway to Henry County and—in regard to the acceptance of Fieldstone Drive by Henry County—said landowners have waived their rights to notice, convening of a jury of view, compensation, and appeal.

WHEREAS, the Henry County Commission deems it to be in the best interest of the County that said road be added into the Henry County Road System and added to the list of County Roads maintained by the Highway Superintendent pursuant to TCA § 54-10-103.



RESOLUTION NO. 4-03-18

**A RESOLUTION OF THE HENRY COUNTY BOARD OF
COMMISSIONERS TO QUITCLAIM CERTAIN REAL ESTATE TO THE
HENRY COUNTY HOSPITAL DISTRICT**

WHEREAS, by the Henry County Hospital District (presently d/b/a Henry County Medical Center and hereinafter "HCMC") was created on March 17, 1953, by Private Acts of 1953, Chapter 176¹ (the "Private Act") of the General Assembly; and

WHEREAS, the Private Act provides:

That said Hospital District shall consist of the following described tract of land, together with all buildings and other improvements thereon and all appurtenances thereunto belonging, located in the First Civil District of Henry County, Tennessee, and more particularly described as follows:

Beginning at the south west corner of this described property at a concrete right-of-way marker in the east right-of-way line of Highway U.S. 79 which is 100 feet east of the center line of said highway; thence south 84 degrees 53 minutes east 1622.7 feet to an iron stake; thence north 04 degrees 02 minutes west 897.8 feet to an iron stake; thence north 85 degrees 32 minutes west 241.60 feet to an iron stake; thence north 05 degrees 26 minutes east 111 feet to a point in the center line of a branch being a part of the north boundary of this described property; thence with the center line of the branch in a north west direction and with its meanderings 665 feet, more or less to a point in the center of said branch; thence leaving branch and running south 11 degrees 50 minutes west 140.0 feet to an iron pin; thence north 78 degrees 08 minutes west 294.3 feet to an iron pin in the east right-of-way line of Highway U.S. 79 which is 100 feet east of the center line of said highway; thence south 19 degrees west 357.5 feet to an iron pin in the east right-of-way line of said highway; thence continuing with said right-of-way line, it being a curved line running in a south west direction, 822 feet approximate to the point of beginning.

The hospital district shall also include the land on which is presently located the Henry County Ambulance Service.

* * *

The Board [of Trustees of HCMC] shall have the responsibility and authority to control the property and facilities of the Hospital District; to purchase real estate with the approval of the Quarterly County Court; to sell, with the approval and authorization of the Quarterly County Court, any portion of the real estate which the District owns and which is considered surplus to its needs in the performance of its

mission; and to execute deeds therefor when authorized so to do by the quarterly County Court . . . ; and

WHEREAS, Henry County never formalized the transfer of the above-described real estate to HCMC by deed of conveyance; and

WHEREAS, to qualify to participate in certain federal programs, HCMC must demonstrate ownership or control of its facilities; and

WHEREAS, in compliance with the Private Act, it is in the best interest of its citizens that Henry County quitclaim the above-described real estate to HCMC, subject to (a) the reservation of all rights contained in the Private Act; (b) reservation of the right to approve and authorize the sale, long-term lease, hypothecation, or any other transfer of rights concerning said real estate; and (c) the right of reversion should the HCMC cease to operate a hospital on said real estate; and

WHEREAS, HCMC has agreed to name Henry County as an additional insured on its liability insurance policies;

NOW, THEREFORE, BE IT RESOLVED by a majority vote of the county legislative body of Henry County, meeting in regular session on this 19th day of March, 2018, that the County Mayor, County Clerk, and County Trustee are authorized and directed to execute a quitclaim deed in the form prepared and approved by the County Mayor and Henry County Attorney conveying the following real estate from Henry County to HCMC in consideration of one (\$1.00) dollar, subject to (a) the reservation unto this legislative body of all rights reserved unto the Quarterly County Court in the Private Act; (b) reservation unto this legislative body of the right to approve and authorize the sale, lease, hypothecation, or any other transfer of rights concerning said real estate; and (c) reservation of the right of reversion unto Henry County should HCMC cease to operate a hospital on said real estate:

Beginning at the south west corner of this described property at a concrete right-of-way marker in the east right-of-way line of Highway U.S. 79 which is 100 feet east of the center line of said highway; thence south 84 degrees 53 minutes east 1622.7 feet to an iron stake; thence north 04 degrees 02 minutes west 897.8 feet to an iron stake; thence north 85 degrees 32 minutes west 241.60 feet to an iron stake; thence north 05 degrees 26 minutes east 111 feet to a point in the center line of a branch being a part of the north boundary of this described property; thence with the center line of the branch in a north west direction and with its meanderings 665 feet, more or less to a point in the center of said branch; thence leaving branch and running south 11 degrees 50 minutes west 140.0 feet to an iron pin; thence


north 78 degrees 08 minutes west 294.3 feet to an iron pin in the east right-of-way line of Highway U.S. 79 which is 100 feet east of the center line of said highway; thence south 19 degrees west 357.5 feet to an iron pin in the east right-of-way line of said highway; thence continuing with said right-of-way line, it being a curved line running in a south west direction, 822 feet approximate to the point of beginning.

BE IT FINALLY RESOLVED, that true copy of this Resolution be spread upon the commission record as of this date.





RESOLUTION NO. 6-03-18

RESOLUTION TO REQUIRE COUNTY BOARD OF EQUALIZATION MEMBERS AND COUNTY BOARD HEARING OFFICERS TO COMPLETE ANNUAL CONTINUING EDUCATION

WHEREAS, the State of Tennessee, through its General Assembly, has mandated that the county legislative body shall by resolution establish a minimum of at least four (4) hours of annual training for county board of equalization members and county hearing officers and the minimum record keeping requirements related to members' certificates of attendance; and

WHEREAS, the General Assembly, in passing Chapter 13 of the Public Acts of 2017, amended *Tennessee Code Annotated* § 67-1-403(e) to provide that such mandatory training shall be a condition of appointment or continued service; and

WHEREAS, the General Assembly, in passing Chapter 13 of the Public Acts of 2017, amended *Tennessee Code Annotated* § 67-1-403(e) to provide that mandatory annual continuing education and training is only required to the extent that such education and training is provided by the Comptroller of the Treasury free of charge.

NOW, THEREFORE BE IT RESOLVED, by the County Legislative Body of Henry County, Tennessee, meeting in regular session on this 19th day of March 19, 2018, at Henry County, Tennessee, that:

SECTION 1. As a condition of appointment or continued service, county board of equalization members and county hearing officers shall complete a minimum of four (4) hours of annual training to include board governance, open meetings requirements, and other topics reasonably related to the duties of the members of the county board of equalization, as provided by the Comptroller of the Treasury.

SECTION 2. Members' certificates of attendance shall be turned over to the assessor of property for preservation for a period of at least three (3) years.

SECTION 3. This Resolution shall be effective upon its passage and approval, the public welfare requiring it.


