**AUDIT COMMITTEE REPORT TO THE  
HENRY COUNTY COMMISSION  
APRIL 8, 2019**

The Henry County Audit Committee consisting of Steve Greer-Chairman, Melanie Dodd-Vice Chairman, Tom Beasley, Kenneth Humphreys, and Bobby Milam is pleased to make the following report to the Henry County Commission.

Our committee met on April 8, 2019 to review the Comptroller's Annual Financial Report for Henry County, Tennessee for the fiscal year ended June 30, 2018. A copy of the minutes of this meeting are attached hereto.

We reviewed Part I Summary of Auditor's results, Part II Findings Relating To the Financial Statements, and Part III Findings and Questioned Costs For Federal Awards. Part II, FINDINGS RELATED TO THE FINANCIAL STATEMENTS were reviewed and discussed in detail. We have attached a copy of FINDING 2018-001 for the Office of Assessor of Property and FINDING 2018-002 for the Office of Director of Schools. Finding 2018-001 dealt with the Assessor of Property not properly prorating improvements and new constructions. Mr. VanDyke presented his response of the finding to the committee. The committee discussed the finding with Mr. VanDyke and concurs with his response to the comptroller. Finding 2018-002 was reviewed and discussed with Dr. Brian Norton, Director of Schools. The finding indicated that internal controls with regard to the Purchasing and Payroll Software did not have adequate application controls. Dr. Norton explained his corrective action response to the findings and the committee concurs with his response. Both corrective action plans are attached hereto.

The Committee discussed the Best Practice comment with regard to adopting a Central System of Accounting, Budgeting, and Purchasing. After discussion with Mayor Greer and Budget Director Hollingsworth, no action was taken. Prior-year Financial Statement findings were acknowledged as being corrected.

We further acknowledge that the County Mayor made the Committee aware of the opportunity for a representative of the Division of Audit to meet with the Committee or individual members to discuss any area of the audit.

Being no further information to report, the Audit Committee respectfully presents this report to the Henry County Board of Commissioners for its approval.

## PART II, FINDINGS RELATING TO THE FINANCIAL STATEMENTS

Findings and recommendations, as a result of our audit and the annual monitoring report performed by the state Division of Property Assessments, are presented below. We reviewed these findings and recommendations with management to provide an opportunity for their response. Written responses for all findings are paraphrased and presented following each finding and recommendation. Management's corrective action plans, whether related to the financial statements or federal awards, are presented separately in the Management's Corrective Action Plan in the Single Audit Section of this report. Findings relating specifically to the audit of federal awards, if any, are separately presented under Part III, Findings and Questioned Costs for Federal Awards.

### OFFICE OF ASSESSOR OF PROPERTY

FINDING 2018-001

#### **THE ASSESSOR DID NOT PROPERLY PRORATE IMPROVEMENTS AND NEW CONSTRUCTION**

(Noncompliance Under *Government Auditing Standards*)

The assessor did not properly prorate improvements and new construction. Assessors are required to add new construction and improvements and to prorate their values for the portion of the year following their date of completion. Section 67-5-603(b)(1), *Tennessee Code Annotated*, provides that for the year in which an improvement or building is completed, the assessment, or increase in assessment, shall be prorated for the portion of the year following the date of its completion. This deficiency can be attributed to management's failure to properly comply with state statute and resulted in an incorrect assessed value on the affected properties.

### RECOMMENDATION

The assessor should properly prorate new construction and improvements as required by state statute.

### MANAGEMENT'S RESPONSE – ASSESSOR OF PROPERTY

As of August 1, 2018, all new construction will be inspected prior to September 1 of that tax year. If the structure is not completed by January 1, a follow-up inspection will be done prior to September 1, and the structure will be prorated as of the completion date that the contractor and owner supply.

If the structure has been under construction for less than one year and not completed as of September 1, it will be placed on the tax roll the following year. If it is still not completed after one year, the structure will be placed on the tax roll at a prorated amount based on cost of material and labor as of that date.

Notices of completion will be verified with the owners and contractors, so the actual completion date is accurate and is not just the original estimate given by an individual contractor.

**OFFICE OF DIRECTOR OF SCHOOLS**

**FINDING 2018-002**

**THE PURCHASING AND PAYROLL SOFTWARE DID NOT HAVE ADEQUATE APPLICATION CONTROLS**  
(Internal Control – Significant Deficiency Under *Government Auditing Standards*)

In-lieu-of using official prenumbered checks, the office generated checks on blank check stock. Because the software provided users the ability to change the computer-generated check number, a gap in check numbers could be created. Also, the application allowed users to print checks multiple times with no indication of a reprint. This process makes it difficult to account for all checks. Sound business practices dictate that proper application controls be implemented. Because management had not determined the risk associated with this functionality, inappropriate system activity could occur. When this deficiency was brought to management's attention in April 2018, the office implemented the use of prenumbered check stock.

**MANAGEMENT'S RESPONSE – DIRECTOR OF SCHOOLS**

We concur with this finding. The plan of action to correct this was implemented immediately upon notification of the deficiency. We ordered prenumbered check stock for all three funds in April. The new stock was put into use when it arrived in early May.

## **BEST PRACTICE**

Accounting literature describes a best practice as a recommended policy, procedure, or technique that aids management in improving financial performance. Historically, a best practice has consistently shown superior results over conventional methods.

The Division of Local Government Audit strongly believes that the item noted below is a best practice that should be adopted by the governing body as a means of significantly improving accountability and the quality of services provided to the citizens of Henry County.

### **HENRY COUNTY SHOULD ADOPT A CENTRAL SYSTEM OF ACCOUNTING, BUDGETING, AND PURCHASING**

Henry County does not have a central system of accounting, budgeting, and purchasing. Sound business practices dictate that establishing a central system would significantly improve internal controls over the accounting, budgeting, and purchasing processes. The absence of a central system of accounting, budgeting, and purchasing has been a management decision by the County Commission resulting in decentralization and some duplication of effort. We recommend the adoption of the County Financial Management System of 1981 or a private act, which would provide for a central system of accounting, budgeting, and purchasing covering all county departments.
