outbreaks in each county;

WHEREAS, no school district should experience loss of funding or other adverse effects based upon the unprecedented circumstances created by the COVID-19 pandemic which could result in loss of overall student membership during the 2020-2021 school year;

RESOLUTION NO. 7-10-20

A RESOLUTION OF THE HENRY COUNTY, TENNESSEE BOARD OF COMMISSIONERS TO APPROVE THE FIRST AMENDMENT TO AGREEMENT FOR BROADBAND ACCESS GRANT

WHEREAS, Henry County, Tennessee ("the County") and West Kentucky and Tennessee Telecommunications Cooperative, Inc. ("WK&T"), having an office at 100 WK&T Technology Drive, Mayfield, Kentucky 42066 (sometimes referred to collectively as the "Parties" or individually as a "Party") entered into an Agreement to Provide Match Funding for Broadband Access Grant on or about September 21, 2020 (the "Agreement"); and

WHEREAS, said Agreement contemplates that WK&T will install broadband networks in underserved areas of the County; and

WHEREAS, said Agreement provides that to fund the project contemplated in the Agreement: (a) \$2,000,000 in grant funding would be obtained; (b) WK&T would pay the balance necessary over and above the grant to construct a broadband network capable of connecting at least 1,000 residences located in underserved areas of the County to WK&T's broadband network; and (c) the County would pay WK&T \$3,000,000 (more if paid in installments) in the form of service fees; and

WHEREAS, the Parties contemplate that (including all funding sources referenced in the Agreement) it will cost \$8,000,000 to construct the broadband network contemplated in the Agreement; and

WHEREAS, the Parties wish to amend Section 4.2 of said Agreement to allow the broadband network construction area to be expanded if additional funding sources becomes available;

NOW THEREFORE, the Parties agree as follows:

Section 4.2 of the Agreement is deleted and replaced by the following paragraph:

- 4.2 WK&T will apply at least \$3,000,000 of its own funds toward constructing the broadband network contemplated in the Agreement, plus any additional amount necessary to fulfil its commitments under this Agreement. WK&T will pursue grants (over and above the \$2,000,000 grant contemplated in the *Conditions Precedent* Section of this Agreement) and other funding opportunities from federal, state and local government sources, WK&T sources, and any other available sources.
 - 4.2.1. Should WK&T obtain additional funding for this project over and above the \$2,000,000 grant contemplated in the Agreement, then either at WK&T's option:

- a. The additional funding shall be used solely to expand the geographic area of the broadband network beyond the area contemplated in the Agreement. (*I.e.*, the total cost of installation of the broadband network will be the initial \$8,000,000 estimate plus the amount of the additional funding, and the number of residences with access to WK&T's broadband network will increase accordingly.)
- b. (i) the geographic area shall remain as contemplated in the Agreement; (ii) the payment required by Section 4.1 to be made by Henry County to WK&T shall be reduced by an amount equal to one-half of the total amount of the additional funding and; and (iii) the \$3,000,000 minimum funding commitment of WK&T required by Section 4.2 of this Agreement shall be reduced by an amount equal to one-half of the total amount of the additional funding.
- 4.2.2. If WK&T obtains additional funding, WK&T shall promptly notify the County in writing of the amount (and any restrictions on use of the funds) of funding and whether WK&T intends to use such funding in the manner described in subsection 4.2.1 (a) or (b) above; after WK&T notifies the County of its intended use of the additional funding, that use may only be modified by the mutual agreement of the Parties.
- 4.2.3. In no event shall Henry County's financial obligation under Section 4.1 of the Agreement be increased.
