WHEREAS, with respect to COVID-19 and the on-set of the pandemic, one of the closures of the Henry County Medical Center included stopping construction in Spring, 2020 and caused delays with various project; and

WHEREAS, pursuant to Section 4.06 of the Loan Agreement by and among the Public Building Authority of the City of Clarksville, Tennessee, Henry County Tennessee (the "County") and First Tennessee Bank National Association (now First Horizon Bank) (the "Bank"), hereby agree that the term 36 months is amended to be 48 months in the Loan Agreement;

WHEREAS, the Board of Trustees of the Medical Center has requested that the Henry County Commission authorize the withdrawal period of Series 2018 Loan be extended from a maximum period of 36-month withdrawal period to a 48-month period;

WHEREAS, the Bond is to be secured by and contain such terms and provisions as set forth in a Bond Purchase Agreement, entered into between the Authority and the purchaser of the Bond (the "Purchaser").

Pursuant to Section 4.06 of the Loan Agreement by and among the Public Building Authority of the City of Clarksville, Tennessee, Henry County Tennessee (the "County") and First Tennessee Bank National Association (now First Horizon Bank) (the "Bank"), dated February 1, 2018 (the "Loan Agreement"), the County was allowed a maximum period of 36 months in which to draw the proceeds of the Loan. The County has requested that the Bank extend this draw period for an additional 12 months and the Bank has agreed to do so.

Accordingly, the County and the Bank hereby agree that the term "thirty-six (36) months" in Section 4.06 of the Loan Agreement is hereby amended to be "forty-eight (48) months".

Further, the County and the Bank hereby agree that the term "thirty-six months" in Section 4.08 of the Loan Agreement is hereby amended to be "forty-eight months".

Lastly, the Bond is modified to change the term "thirty-six months" in clause (iii) of the last paragraph on page 3 of the Bond to read "forty-eight months".

All capitalized terms not defined in this letter shall have the meaning assigned to such terms in the Loan Agreement.
