Our committee met on April 12, 2021 to review the Comptroller's Annual Financial Report for Henry County, Tennessee for the fiscal year ended June 30, 2020. A copy of the minutes of this meeting is attached hereto.

We reviewed Prior Year Financial Statements Findings for the year ended June 30, 2020, Part I Summary of Auditor's Results, Part II Findings Related to the Financial Statements, Part III Findings and Questioned Costs for Federal Awards, Management's Corrective Action Plan for the Year Ended June 30, 2020, and the Corrective Action Plan.

### **RESOLUTION #2-4-21**

### A RESOLUTION TO URGE THE GENERAL ASSEMBLY TO ENACT HB 1625 PERTAINING TO THE HENRY COUNTY GENERAL SESSIONS COURT JUDGE'S COMPENSATION

WHEREAS, the Henry County General Sessions Court Judge presides over a large volume of small claims civil; misdemeanor criminal, and juvenile court cases; and

WHEREAS, it is in the best interest of the citizens of Henry County, Tennessee, that the General Sessions Court Judge's compensation be set at a level that would encourage highly qualified attorneys to seek the office of General Sessions Court Judge and which will adequately and fairly compensate the General Sessions Court Judge for handling the volume of cases; and

WHEREAS, the private act known as House Bill #1625 would set the Henry County General Sessions Court Judge's compensation at an amount equal to the compensation received by chancellors and Circuit Court judges; and

WHEREAS, the Henry County Bar Association, an association of attorneys who practice in Henry County, Tennessee, has expressed support for House Bill #1625;

NOW, THEREFORE, BE IT RESOLVED by a two-thirds (2/3) vote of the county legislative body of Henry County, meeting in regular session on this 19<sup>th</sup> day of April, 2021, that the members of the General Assembly representing the people of Henry County (and all other members of the General Assembly) are urged to vote in support of House Bill #1625;

BE IT FURTHER RESOLVED, that the General Assembly is requested to include in House Bill #1625 a provision consistent with TENN, CODE ANN, § 16-15-5006 allowing the Henry County Commission to set a county litigation tax exceeding \$6 per civil case and criminal conviction up to the amount necessary to fund the Henry County general sessions judge's compensation mandated by House Bill #1625 (or any prior or subsequent Private Act).

**BE IT FURTHER RESOLVED,** that copies of this resolution be mailed by the County Clerk to the members of the General Assembly representing the people of Henry County.

**BE IT FINALLY RESOLVED,** that true copy of this Resolution be spread upon the commission record as of this date.

JOHN PENN RIDGEWAY HENRY COUNTY MAYOR AN ACT to amend Chapter 82 of the Private Acts of 1989; and any other acts amendatory thereto, relative to the compensation of the general sessions judge of Henry County.

### BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 82 of the Private Acts of 1989, and any other acts amendatory thereto, is amended by deleting the second sentence from Section 6 and by adding at the end of Section 6 the following:

Effective September 1, 2022, the annual salary of the general sessions judge of Henry County is set at an amount equal to the amount received annually by circuit court judges and chancellors. On July 1, 2023, and every July 1 thereafter, the annual salary of the general sessions judge of Henry County must be adjusted in accordance with the provisions of Tennessee Code Annotated, Section 8-23-103(2). The salary provided for the general sessions judge must be paid in twelve (12) equal monthly installments.

SECTION 2. Any private act, or part thereof, affecting Henry County that is in conflict herewith is hereby repealed.

SECTION 3. This act has no effect unless it is approved by a two-thirds (2/3) vote of the legislative body of Henry County. The approval or non-approval of this act must be proclaimed by the presiding officer of the Henry County legislative body and certified to the secretary of state.

SECTION 4. For the purpose of approving or rejecting the provisions of this act, it is effective upon becoming a law, the public welfare requiring it. For all other purposes, it is effective upon being approved as provided in Section 3.

It is my understanding that the Henry County Commission will soon consider a measure to bring the base salary of the Henry County General Sessions and Juvenile Court Judge into parity with that of the other full time judges who serve Henry County. A decision to make such an adjustment, to be effective in 2022, is fully warranted for two primary reasons.

First, the job has evolved to require the full time professional attention of the attorney performing the duties. I know the effort that has been brought to the job by the fine lawyers who have served there in the past and at present. Each has devoted time and attention to the demands of the job in a manner equal to that of the other judges who work in Henry County. To compensate them equally will be fundamentally fair.

Second, in order to attract the best qualified lawyers to perform this job in the future, it is prudent to structure the compensation in a way that values their work equally with that of other similar roles. The concept is simple – in order to hire the best person for the job the pay must be competitive.

Henry County has the largest docket of any county court in the 24th Judicial District of Tennessee. Your citizens benefit from the efficiency that is found in those courts. I submit that this small step will assist in preserving the well qualified and efficient operation of your local courts well into the future.

WHEREAS, Tennessee Code Annotated, Section 57-5-105, authorizes county legislative bodies to enact a rule restricting the sale of beer within 300 feet of a residential dwelling provided the owner of the residential dwelling appears, in person, before the beer board and objects to the issuance of the permit (the "300-foot Rule"); and

WHEREAS, Henry County legislative body previously adopted the 300-foot Rule by prior resolution; and

WHEREAS, the 300-foot Rule may not presently be enforceable; and

WHEREAS, there are not currently any beer permits in Henry County that were invalidly issued in violation the 300-foot Rule; and

WHEREAS, it is in the best interest of Henry County that the county legislative body reinstate the 300-foot Rule;

**NOW, THEREFORE BE IT RESOLVED** by the Henry County Board of Commissioners meeting in regular session at Paris, Henry County, Tennessee, on the 19th day of April, 2021, that:

<u>SECTION 1.</u> There is hereby enacted and reinstated a 300 Foot Rule for the sale of beer in Henry County. This rule provides that no permit for the sale of beer will be issued for any location within 300 feet of a residential dwelling, measured from building to building, provided, the owner of the residential dwelling appears, in person, before the county beer board and objects to the issuance of the permit.

SECTION 2. (A) This rule does not apply to locations where a beer permit has been issued prior to the adoption of this rule, or to applications for a change in the permittee at such locations. (B) In accordance with Tennessee Code Annotated, Section 57-5-109(c): the grandfather provision of Section 2 subsection (A) does not apply if there has been (or subsequently is) a six-month gap in beer sales at the location.

**BE IT FINALLY RESOLVED** that this Resolution shall be effective upon its passage and approval, the public welfare requiring it. The County Clerk shall cause a true and correct copy of this Resolution to be spread upon the minutes of this meeting.

### **FARM RENTAL CONTRACT**

This contract made and entered into the date below set forth by and between HENRY COUNTY, TENNESSE (hereinafter called "Owner") and Clint Diggs (hereinafter called "Tenant").

### WITNESSETH:

Subject to the terms and conditions set forth, said Owner leases to Tenant and said Tenant leases from the Owner that certain real estate located in Henry County, Tennessee consisting of 24.0 acres on the east side of the North-South runway of the Henry County Airport.

The terms and conditions of this agreement are as follows:

FIRST: The term of this Agreement is May 1, 2021 to December 31, 2025.

SECOND: Tenant shall have the full management and all responsibility relative to the leased premises.

THIRD: Tenant is to receive all income derived from the leased premises.

FOURTH: For the entire lease term, Tenant shall pay Owner Five Hundred Dollars (\$500.00) per acre in five equal installments as follows: (a) Two Thousand Four Hundred Dollars (\$2,400.00) upon execution of this contract and (b) Two Thousand Four Hundred Dollars (\$2,400.00) upon payable on or before the first (1st) day of January of each year of the lease term thereafter.

FIFTH: Tenant shall have possession of the leased premises from May 1, 2021 until December 31, 2025.

SIXTH: The Tenant may grow row crops on the leased premises and shall manage the leased premises in a husband like manner. Tenant shall follow improved, modern farming practices. Tenant shall not use the leased premises for any other purpose.

SEVENTH: Tenant shall furnish all seed, fertilizer, and lime used incident to farming the leased premises.

EIGHTH: Owner shall in no event be liable to Tenant for damage to crops on the leased premises. The owner reserves the right to cross the leased premises to access a weather station, and without limiting the generality of the foregoing the Owner shall not be responsible for crop damage resulting from accessing the weather station or other airport improvements.

NINTH: This lease shall terminate at 11:59 PM on December 31, 2025, and shall not automatically renew. Tenant agrees not to holdover; even in the event Tenant holds over in violation of this agreement, no holdover, periodic, or other tenancy in the leased premises shall result.

TENTH: In the event of a breach of any of the provisions of this contract by the Tenant, the Owner may at its option enter and take possession of said property immediately and the Tenant forfeits any rights he may have had hereunder.

The Owner, by and through its County Mayor, John Penn Ridgeway, executes this lease, together with the Tenant, Clint Diggs, in duplicate originals.

### A RESOLUTION OF THE HENRY COUNTY BOARD OF COMMISSIONERS TO APPROVE A CHANGE IN A PAYMENT IN LIEU OF TAXES (PILOT) AGREEMENT

Dana Sealing Products, LLC

WHEREAS, on July 30, 2019 on Resolution #4-07R-19, the Henry County Board of Commissioners ("Commission") approved a payment in lieu of taxes ('PILOT") at the request of Dana Sealing Products, LLC ("Dana"), pursuant to and in accordance with the provisions of Tennessee Code Annotated §§ 7-53-101 *et seq.*, as amended (the "Act") to be entered into by and between Dana and The Industrial Development Board of the City of Paris, Tennessee ("IDB Board");

WHEREAS, the IDB Board was authorized to purchase certain industrial equipment from Dana in an aggregate amount not to exceed \$10,000,000.00 to be used on Dana's site in Henry County, and then lease the equipment back to Dana, having the effect of abating ad valorem property taxes on the industrial equipment for a period of seven (7) years; provided, however, that combined full-time employment by Dana and any of its related or affiliated entities located at the same site be maintained at 552 jobs during the lease term, with an option for the IDB Board to modify or terminate the lease with Dana if this full time employment requirement is not met;

**WHEREAS**, the IDB Board has received the request of Dana, based upon the actual cost of the capital investment in industrial equipment, to increase the aggregate total amount of such equipment purchases by the IDB Board to \$13,500,000.00; and

WHEREAS, consummation of the transaction herein contemplated is in the best interest of the citizens of Henry County, Tennessee, as it will keep, maintain, and expand employment opportunities and will thereby promote industry, trade, commerce and housing construction in Henry County, Tennessee, thereby furthering the public purpose in accordance with Act.

**NOW, THEREFORE, IT IS HEREBY RESOLVED** by Henry County, Tennessee, as follows:

- 1. The IDB Board is hereby authorized pursuant to and in accordance with the Act, to enter into an amended PILOT Incentive transaction with Dana, under the terms and conditions that Dana will sell or otherwise transfer to the IDB Board industrial equipment used at its site at fair market value in an amount not to exceed Thirteen Million Five Hundred Thousand Dollars (\$13,500,000.00), and the IDB Board shall lease or otherwise grant to Dana the use of the industrial equipment.
- 2. The IDB Board is further authorized to enter into an amended PILOT Incentive transaction authorized by the Act, having the effect of abating ad valorem property taxes on the contemplated industrial equipment for a period of seven (7) years; provided, however, that combined full-time employment by Dana and any of its related or affiliated entities located at the same site be maintained at 552 jobs during the lease term, with an option for the IDB Board to modify or terminate the lease with Dana if this full time employment requirement is not met.
- 3. To the extent otherwise required under the law, The Industrial Development Board of the City of Paris, Tennessee, has the required authority to act on behalf of Henry County, Tennessee to implement the PILOT incentive transaction described above, and the Commission hereby ratifies any actions heretofore taken to implement said transaction.
