Please accept this letter as notice of the 2-year extension available per the contract dated July 1, 2020, for the solid waste collection services.

Effective July 1, 2023, the first year of the extended term, the rates for residential collection will increase to \$19.25, up from \$18.20. The extra cart rate will remain \$6.00. The rates for year 2 will increase 4% on the anniversary date.

Due to the continued rising costs of fuel and equipment, and the high rates of inflation, these rates are necessary for us to continue to provide the safe, dependable service the County residents expect. The current CPI is 4.9% and reached an all time high of 9.1% in June of 2022. When this contract started the CPI was 0.7%. The cost of fuel is currently at \$3.80 per gallon. When the contract started fuel was \$2.44 per gallon. Fuel reached a high of \$5.81 per gallon in June 2022 and was over \$5.00 per gallon for most of 2022. During the current 3 year extended term of the agreement, we only received a 2.5% annual increase, which didn't allow us to keep up with the rising costs to do business.

### FIRST AMENDMENT TO CONTRACT FOR SOLID WASTE COLLECTION & DISPOSAL SERVICES

THIS FIRST AMENDMENT TO CONTRACT FOR SOLID WASTE COLLECTION & DISPOSAL SERVICES (this "Amendment") is made effective as of July 1, 2020 (the "Amendment Effective Date"), by the County of Henry (the "County") and Barker Brothers Waste, Inc. dba Republic Services ("Contractor").

#### **BACKGROUND**

WHEREAS, the County and Contractor are parties to a Contract for Solid Waste Collection & Disposal Services, dated July 1, 2015 (the "Contract").

WHEREAS, the Contract is set to expire on June 30, 2020 and the parties desire to extend the Contract as provided herein.

WHEREAS, upon the mutual written consent of the County and Contractor, which consent shall not be unreasonably withheld, the terms of the Contract may be modified.

WHEREAS, the parties wish to further amend the Contract as set forth below.

#### **AGREEMENT**

The parties agree to amend the Contract as follows, effective as of the Amendment Effective Date:

- 1. <u>Recitals</u>. The recitals set forth above are true and correct and are hereby incorporated herein by reference. Any capitalized terms used herein but not defined have the same meaning as that ascribed to them in the Contract.
- 2. Extension of Term. The term of the Contract shall continue in effect until June 30, 2023 (the "Term"). The Contract may be extended beyond the Term for an additional two (2) year period as well as extending an additional five (5) year period thereafter upon the mutual written agreement of the parties.
  - 3. Rates. Rates for collection and disposal services are set forth on Exhibit A attached hereto.
  - 4. <u>Authority</u>. Each individual signing this Amendment expressly represents and warrants that he/she has the right, legal capacity and full authority to execute this Amendment.
  - 5. <u>Conflicting Terms</u>. In the event of a conflict between the terms of this Amendment and those contained in the Contract, the terms of this Amendment will control and prevail.

- Ratification. Except as specifically provided in this Amendment, each and every provision of the Contract, as amended through the date hereof, remains, and is, in all respects, in full force and effect.
- 7. Counterparts. This Amendment may be executed in any number of counterparts, including facsimile and .pdf, each of which constitutes an original and all of which, collectively, constitute one and the same instrument. The signatures of the parties need not appear on the same counterpart.
- 8. <u>Miscellaneous</u>. (i) The provisions hereof are binding upon and inure to the benefit of the parties and their respective successors and assigns; and (ii) this Amendment and the Contract constitute the entire understanding between the parties in respect to the subject matter hereof.

#### RESOLUTION NO. 12-6-23

A RESOLUTION AUTHORIZING THE ISSUANCE OF TAX ANTICIPATION NOTES, SERIES 2023, IN THE AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED \$4,000,000 OF HENRY COUNTY, TENNESSEE; REPEALING AND REPLACING RESOLUTION NO 11-5-23; MAKING PROVISION FOR THE ISSUANCE, SALE AND PAYMENT OF SAID NOTES; ESTABLISHING THE TERMS THEREOF AND THE DISPOSITION OF PROCEEDS THEREFROM.

WHEREAS, by Sections 9-21-101 et seq., Tennessee Code Annotated, counties in Tennessee are authorized through their respective governing bodies to issue and sell tax anticipation notes of said counties for the purpose of meeting appropriations in anticipation of the collection of taxes and revenues; and

WHEREAS, the Board of County Commissioners of Henry County, Tennessee, has heretofore determined that it is necessary and advisable to issue up to \$4,000,000 in aggregate principal amount of tax anticipation notes for the purpose of meeting appropriations from its Hospital Fund (the "Hospital Fund") during the County's 2023-2024 fiscal year; and

WHEREAS, it is the intention of the Board of County Commissioners to adopt this resolution for the purpose of authorizing the issuance of up to \$4,000,000 in aggregate principal amount of said notes, providing for the issuance, sale and payment of said notes, establishing the terms thereof and the disposition of proceeds therefrom.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Henry County, Tennessee as follows:

<u>Section 1</u>. <u>Authority</u>. The notes authorized by this resolution will be issued pursuant to Section 9-21-101 <u>et seq.</u>, Tennessee Code Annotated, and other applicable provisions of law.

<u>Section 2</u>. <u>Definitions</u>. The following terms shall have the following meanings in this resolution unless the text expressly or by necessary implication requires otherwise:

- (a) "County" means Henry County, Tennessee;
- (b) "Governing Body" means the Board of County Commissioners of the County; and
- (c) "Notes" means the not to exceed \$4,000,000 Tax Anticipation Notes, Series 2023 of the County, authorized to be issued by this resolution; and
- (d) "Registration Agent" means the County Trustee of the County or such other person or entity as may be appointed by the County Mayor to act as registration and paying agent for the Notes.

Section 3. Authorization and Terms of the Notes. For the purpose of providing funds to meet appropriations from the County's Hospital Fund and to pay costs incident to the issuance and sale of the Notes as more fully set forth in Section 7 hereof, there are hereby authorized to be issued tax anticipation notes of the County in the aggregate principal amount of not to exceed \$4,000,000. The Notes shall be issued in fully registered form, without coupons, shall be designated as "Tax Anticipation Notes, Series 2023", and shall be dated the date of their issuance. The Notes shall bear interest at a federally taxable rate or rates not to exceed the maximum interest rate allowed by law, payable with such frequency, not more often than monthly, as is agreed upon with the purchaser of the Notes, and the Notes shall mature on such date as is agreed upon with the purchaser thereof but not later June 30, 2024. Subject to Section 7 hereto, the Notes may be prepaid at any time. In no event shall the principal amount of the Notes and any other tax anticipation notes payable from the Hospital Fund exceed 60% of the appropriations to be made from the Hospital Fund during the County's 2023-2024 fiscal year.

The Registration Agent is hereby authorized and directed to maintain a note registration record with respect to the Notes, to authenticate and deliver the Notes as provided herein, either at original issuance, upon transfer, or as otherwise directed by the County, to effect transfers of the Notes, to give all notices of redemption as required herein, to make all payments of principal and interest with respect to the Notes as provided herein and to cancel and destroy Notes which have been paid at maturity or upon earlier redemption or submitted for exchange or transfer.

The Notes shall be payable, principal, premium, if any, and interest, in lawful money of the United States of America at the offices of the Registration Agent. The Registration Agent shall make all interest payments with respect to the Notes on each interest payment date directly to the registered owners as shown on the Note registration records maintained by the Registration Agent as of the close of business on the fifteenth day of the month next preceding the interest payment date (the "Regular Record Date") by check

or draft mailed to such owners at their addresses shown on said Note registration records or by such other means as may be approved by the County Trustee, without, except for final payment, the presentation or surrender of such registered Notes, and all such payments shall discharge the obligations of the County in respect of such Notes to the extent of the payments so made. Payment of principal of the Notes shall be made upon presentation and surrender of such Notes to the Registration Agent as the same shall become due and payable.

Any interest on any Note which is payable but is not punctually paid or duly provided for on any interest payment date (hereinafter "Defaulted Interest") shall forthwith cease to be payable to the registered owner on the relevant Regular Record Date; and, in lieu thereof, such Defaulted Interest shall be paid by the County to the persons in whose names the Notes are registered at the close of business on a date (the "Special Record Date") for the payment of such Defaulted Interest, which shall be fixed in the following manner: the County shall notify the Registration Agent in writing of the amount of Defaulted Interest proposed to be paid on each Note and the date of the proposed payment, and at the same time the County shall deposit with the Registration Agent an amount of money equal to the aggregate amount proposed to be paid in respect of such Defaulted Interest or shall make arrangements satisfactory to the Registration Agent for such deposit prior to the date of the proposed payment, such money when deposited to be held in trust for the benefit of the persons entitled to such Defaulted Interest as in this Section provided. Thereupon, not less than ten (10) days after the receipt by the Registration Agent of the notice of the proposed payment, the Registration Agent shall fix a Special Record Date for the payment of such Defaulted Interest which Date shall be not more than fifteen (15) nor less than ten (10) days prior to the date of the proposed payment to the registered owners. The Registration Agent shall promptly notify the County of such Special Record Date and, in the name and at the expense of the County, not less than ten (10) days prior to such Special Record Date, shall cause notice of the proposed payment of such Defaulted Interest and the Special Record Date therefor to be mailed, first class postage prepaid, to each registered owner at the address thereof as it appears in the Note registration records maintained by the Registration Agent as of the date of such notice. Nothing contained in this Section or in the Notes shall impair any statutory or other rights in law or in equity of any registered owner arising as a result of the failure of the County to punctually pay or duly provide for the payment of principal of, premium, if any, and interest on the Notes when due.

The Notes are transferable only by presentation to the Registration Agent by the registered owner, or his legal representative duly authorized in writing, of the registered Note(s) to be transferred with the form of assignment on the reverse side thereof completed in full and signed with the name of the registered owner as it appears upon the face of the Note(s) accompanied by appropriate documentation necessary to prove the legal capacity of any legal representative of the registered owner. Upon receipt of the Note(s) in such form and with such documentation, if any, the Registration Agent shall issue a new Note or Notes to the assignee(s) in \$100,000 denominations, or integral multiples thereof, as requested by the registered owner requesting transfer. The Registration Agent shall not be required to transfer or exchange any Note during the period commencing on a Regular or Special Record Date and ending on the corresponding interest payment date of such Note, nor to transfer or exchange any Note after the notice calling such Note for redemption has been given, nor to transfer or exchange any Note during the period following the receipt of instructions from the County to call such Note for redemption; provided, the Registration Agent, at its option, may make transfers after any of said dates. No charge shall be made to any registered owner for the privilege of transferring any Note, provided that any transfer tax relating to such transaction shall be paid by the registered owner requesting transfer. The person in whose name any Note shall be registered shall be deemed and regarded as the absolute owner thereof for all purposes and neither the County nor the Registration Agent shall be affected by any notice to the contrary whether or not any payments due on the Notes shall be overdue. Notes, upon surrender to the Registration Agent, may, at the option of the registered owner, be exchanged for an equal aggregate principal amount of Notes of the same maturity in any authorized denomination or denominations.

The Notes shall be signed by the County Mayor and attested by the County Clerk by their respective signatures.

The Registration Agent is hereby authorized to authenticate and deliver the Notes to the original purchaser thereof upon receipt by the County of the proceeds of the sale thereof and to authenticate and deliver Notes in exchange for Notes of the same principal amount delivered for transfer upon receipt of the Note(s) to be transferred in proper form with proper documentation as hereinabove described. The Notes shall not be valid for any purpose unless authenticated by the Registration Agent by the manual signature of an officer thereof on the certificate set forth herein on the Note form.

In case any Note shall become mutilated, or be lost, stolen or destroyed, the County, in its discretion, shall issue, and the Registration Agent, upon written direction from the County shall authenticate and deliver, a new Note of like tenor, amount, maturity and date, in exchange and substitution for, and upon the cancellation of, the mutilated Note, or in lieu of and substitution for such lost, stolen or destroyed Note, or if any such Note shall have matured or shall be about to mature, instead of issuing a substituted Note the County may pay or authorize payment of such Note without surrender thereof. In every case the applicant shall furnish evidence satisfactory to the County and the Registration Agent of the destruction, theft or loss

of such Note, and indemnity satisfactory to the County and the Registration Agent; and the County may charge the applicant for the issue of such new Note an amount sufficient to reimburse the County for the expense incurred by it in the issue thereof.

Section 4. Source of Payment. The Notes shall be payable from the receipt of taxes and revenues in the Hospital Fund during the County's 2023-2024 fiscal year. If the County overestimates the amount of taxes and revenue collected during such fiscal year and it becomes impossible to retire the Notes prior to the close thereof, then the County shall apply to the Comptroller of Treasury within ten (10) days prior to the close of the fiscal year for permission to issue funding bonds to cover the unpaid Notes in the manner provided by Title 9, Chapter 11 of Tennessee Code Annotated or as otherwise provided for in a manner approved by the Comptroller of Treasury.

Section 5. Form of Notes. The Notes shall be in substantially the following form, the omissions to be appropriately completed when the Notes are prepared and delivered:

This Note is one of a total authorized issue aggregating \$4,000,000 and issued by the County for the purpose of meeting appropriations from the County's Hospital Fund during the County's 2023-2024 fiscal year, under and in full compliance with the constitution and statutes of the State of Tennessee, including Sections 9-21-101 et seq., Tennessee Code Annotated, and pursuant to a resolution duly adopted by the Board of County Commissioners of the County on the 20th day of 3023 (the "Resolution").

This Note is payable from the receipt of taxes and revenues in the Hospital Fund during the County's 2023-2024 fiscal year. For a more complete statement of the general covenants and provisions pursuant to which this Note is issued, reference is hereby made to said Resolution.
