Motion was made by Commissioner David Travis Jr. and seconded by Commissioner Paul Neal to accept the Letter of Intent (LOI) from West Tennessee Healthcare, Inc. (WTN) with the current revisions as presented by attorney Angela Humphreys (copy of said LOI is attached to these minutes) and authorize and direct the County Mayor to sign said LOI on behalf of the County if (and after) all the following conditions have been met:

- 1. The Henry County Hospital District (HCMC) Board of Trustees approves the LOI;
- 2. WTN agrees that certain real property known on the maps of the Henry County Assessor as Map 106, parcel 28, and Map 106G, Group C, Parcel 3 (copy of tax maps attached to these minutes) will be omitted from the Proposed Transaction, and HCMC agrees to convey said real property to the Henry County Government within approximately 30 days after the Proposed Transaction closes; and
- 3. WTN agrees that on or before June 17, 2024, it will deliver to the County Mayor and HCMC a preliminary list of material HCMC contracts which will NOT be assumed by WTN as part of the Proposed Transaction; it is understood that this preliminary list may be incomplete (a complete list must be delivered before the County Commission will approve the Definitive Agreements), but WTN must make a good faith effort to include all material contracts in said preliminary list.
